Dear Residents

Re: Online Consultation for the Development of 19 new homes at North Drive, High Cross.

I am writing to inform you of an online consultation being arranged by Beechwood Homes relating to proposals to provide new homes at the above site. We have posted this letter to those residents who immediately border the site i.e. those most directly affected. We appreciate other nearby residents may want to make their views known and we will encourage others to share these details if they so wish.

Who are we?

Beechwood Homes has, over the past 32 years, built a reputation for developing homes of exceptional quality throughout Hertfordshire and the Home Counties. We are a small sized, local company specialising in delivering a wide range of housing from apartments, bungalows and luxury family houses. Being a developer and builder affords us greater control and continuity in our approach to designing and building houses. We focus on producing smaller scale developments to exacting standards, and of exceptional quality. We have met already with some of the parish council, church groups and local residents. We take pride in listening to people's views and factoring these into our proposals wherever viable. Please note this is not a statutory consultation; the local planning authority will conduct this whenever an application is submitted.

The draft Proposals

The development is for the construction of 19 residential dwellings. This will comprise a mix of 12 semi-detached and detached properties ranging across 3, 4 and 5 Bedroom Houses. There will also be a provision of 7 Affordable Houses ranging across 1, 2 and 3 bedroom units. These will be highend properties with a design and appearance to capture the rural setting and character of this location. As part of our proposals we are including the upgrade of North Drive as we see this as an improvement for the local community and neighbouring residents. We are seeking your views on the best option to put forward for pedestrians and vehicle users.

We have also made allowances on this site to assist with improving the drainage features to the south east of this site. This has been agreed in conjunction with the land owner (The Diocese), East Herts Council and David Wilson Homes.

There is a local area of play in the centre of the site which will be open to general public to use.

These properties have been sensitively positioned and designed to minimise the impact on the surrounding properties and to protect their amenities. The site has been designed in a way to protect and retain existing trees.
